Notice under Section 708A (5)

The Company announced the issue of 74,818,393 fully paid ordinary shares on 25 July 2018, as a private placement to sophisticated and institutional investors at \$0.34 per share to raise \$25,438,253 (before costs). For every five (5) new shares subscribed applicants will receive one (1) free attaching option (or approximately 14,963,679 options). The options will be unlisted and are exercisable by payment of 60 cents on or before 31 December 2019.

The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Act").

The shares were issued without disclosure to investors under Part 6D.2 of the Act.

The Company as at the date of this notice has complied with
